WOMENS FITNESS: NPC National Qualifier-Open to all USA NPC Members

WOMENS FIGURE: NPC National Qualifier-Open to all USA NPC Members

WOMENS BIKINI: NPC National Qualifier-Open to all USA NPC Members

NATIONAL QUALIFICATIONS

NATIONAL QUALIFICATIONS: Bodybuilding

Once a competitor places well enough to be nationally qualified-1st and 2nd place at the state level, they maintain the national qualification through 2 calendar years (Nationals and USA's Only). For all other nationals events you will only have 1 year to participate (Jr USA, Team Universe etc). For example if you have place 1st or 2nd on the state level in 2009, you are qualified for the Nationals or USA's up until Dec 2011. For the 1st and 2nd place winners in 2009 on the state level are qualified to participate at the Jr USA, Team Universe etc, until (Dec 2010).

NATIONAL QUALIFICATIONS: FIGURE

Once a competitor places well enough to be nationally qualified (1st, 2nd and 3rd, in each class) on a state level they are eligible for the Junior National, USA and National Figure Championship. For example if you have place 1st, 2nd or 3rd on the state level in 2009, you are qualified for the Nationals or USA's up until Dec 2011. If you place 1st, 2nd, 3rd, 4th or 5th in each class, you are eligible for the Junior USA, Teen Collegiate Master Nationals and Team Universe Figure Championship. For the 1st, 2nd, 3rd, 4th or 5th place winners (2009) on the state level are qualified to participate at the Jr USA, Team Universe etc, until (Dec 2010).

NATIONAL QUALIFICATIONS FOR: BIKINI

- Top 5 places in each class are eligible for the Junior USA Bikini Championship, Junior National Bikini Championships or the USA Bikini Championship, Team Universe Bikini Championships, IFBB North American Bikini Championship or National Bikini Championship. The following placing will qualify competitors for one year for the NPC national level Bikini contests:
 - Top 5 places in each class at National Qualifying events only.

NATIONAL QUALIFICATIONS FOR: FITNESS

Once a competitor places well enough to be nationally qualified (1st, 2nd and 3rd, in each class) on a state level they are eligible for the Junior National, USA and National Figure Championship. For example if you have place 1st, 2nd or 3rd on the state level in 2009, you are qualified for the Nationals or USA's up until Dec 2011. If you place 1st, 2nd, 3rd, 4th or 5th in each class, are eligible for the Junior USA, Teen Collegiate Master Nationals and Team Universe Figure Championship. For the 1st, 2nd, 3rd, 4th or 5th place winners in 2009 on the state level are qualified to participate at the Jr USA, Team Universe etc, until (Dec 2010).

General Contest Information

- This competition is open to all competitors 18 years and older.
- This contest is to emphasize physical fitness, beauty, health and poise.
- Presentable regulation swimsuits must be worn. Thongs or T-back swimsuits are not permitted. Acceptable 2-piece swimsuits are swimsuits that are 2 separate pieces that covers 50% of the glute area, triangle top or push-ups. Swimsuits can be solid, multi-colored or metallic. Decorations are allowed such as, studs, sequins, rhinestones, ribbons, etc., and jewelry may be worn. Please bring your TWO PIECE swimsuit and high heels to prejudging and evening performances. (Points will be deducted for unacceptable swimsuits)
- The NPC Judging Criteria for Women's Figure will be as follows: When judging a figure competition, the judges shall assess the athleticism of the physique. This is not a bodybuilding contest, **SEPARATION AND STRIATIONS SHOULD NOT BE REWARDED.** The muscle tone should appear firm and round with a small amount of body fat over the muscle. The figure competitions provide alternative contest for athletic women to train, but do not wish to gain muscle size, vascular, or "cuts" required for bodybuilding competitions or the physical demands of a fitness routine.
- **FIGURE COMPETITION ROUNDS AND RULES:**
Judges rate the competitors on three important elements:
 - **FEMININITY:** A combination of beauty, athleticism and body shape. The tight-skinned, no-fat appearance gives the finished look to a championship feminine physique.
 - **SYMMETRY:** Related to the overall body parts and muscle groups. All areas should show relatively equal development, overall degree of athleticism and proportion.
 - **PRESENTATION:** Includes the athlete's posture, grooming, facial beauty and healthy appearance. Make-up should be finished and feminine. Keep in mind your face makeup should be dark enough to match your body make-up and skin tone. Hair can be of any particular style, including up or down, but should be moved off your back during quarter turns.
 - **PRE-JUDGING:** TWO PIECE swimsuit with high heels. The contestants will present quarter turns with other contestants.
- **FINALS: NIGHT SHOW: ALL CONTESTANTS MUST BRING: TWO PIECE swimsuit and high heels.** Only the winner from each height class will be re-judged for the overall.
- Contestants must report to the Honolulu Club (932 Ward Ave.) on Thursday, April 16, 2009 from 6-7pm to determine the height classification. Check in at the front desk on the 7th floor.
- **PRE-JUDGING:** Figure, Fitness and Bikini Contestants must check in to the Pacific Beach Hotel, Grand Ballroom on contest day for pre-judging at 6:45am. We will have a mandatory practice for the figure, fitness and bikini competitors at 7am. Right after practice, we will be having a mandatory meeting for all competitors with the Promoters and the NPC Chairperson. There will be **NO EXCEPTIONS.** Those who fail to show for pre-judging will automatically be disqualified from this event.

- No monetary prizes may be given at the amateur level.
